Between fiscal year 2019-2020 and year-to-date, we added 6 new funds: St. Foundation Coordinator
Casimir Parish in Hammond, Sacred Heart Parish in Whiting, St. Paul's Parish in Valparaiso, the Staley
Scholarship for Andrean High School, two funds for St. Patrick's in Chesterton, one for the Church and
the second is the James & Barbara Thorstad Scholarship for St. Patrick's School.

Last year, Lakeside Wealth Management, our investment partner, was merged into CAPTRUST Financial Advisors, a 34-year old company with over \$390 billion of client assets under advisement, providing us with additional leverage for the FOUNDATION'S investments, through sound financial advice, integrity and a commitment to service beyond expectations.

In early August, the FOUNDATION, along with CAPTRUST, hosted a virtual seminar for Fund holders, pastors and board members to outline the progress of the FOUNDATION'S portfolio and to explain the current market position. Under the direction of our Finance Committee and CAPTRUST advisors, we were able to make several adjustments to the investments of the FOUNDATION and minimize the effect of the COVID-19 market. As of December 1, 2020, the FOUNDATION has reached the \$11 million mark.

Thank you to all who support the 41 distinct endowment funds (see pages 6 & 7) that are part of the Catholic Foundation family.

2020 Mercy Fund Grant Recipients

The year 2020 has been one of many challenges and the coronavirus impacted the regular Mercy Fund application cycle. The Mercy Fund Grants Committee responded by selecting ministries that had previously applied for assistance and awarded this year's grants to agencies who directly serve the poor and feed the hungry. The Mercy Fund is the only endowment fund in the CATHOLIC FOUNDATION that provides annual grants. Every year the Grant Committee reviews applications from programs that serve those in need. Good Samaritans, St. Michael Church — Schererville

This ministry provides food for those in need in the areas surrounding Schererville, serving approximately 8 families per week with food and 4 or 5 families with rent or utility assistance. Volunteers also refer families to other agencies when the program is not able to meet their need.

St. Joseph Soup Kitchen – Hammond

Manna for Hammond feeds the hungry, homeless people down on their luck, families that can't make ends meet, every day, Monday thru Friday from 12 noon to 1:00 pm, come rain or shine. On any given day they average 90-100 people. Because of COVID the Soup Kitchen has switched from serving cafeteria style to providing brown bag lunches.

Society of St. Vincent de Paul District Council of Gary, Inc. Special Works Fund

Provides food for the hungry, shelter for the homeless, clothes for the naked, and shares spiritual assistance to local neighbors in need through home visits. The Society of St. Vincent de Paul in the Diocese of Gary consists of 24 conferences, which provide emergency food and financial assistance for utilities, housing, medication, and so much more.

St. Stanislaus Community Food Pantry — East Chicago

The monthly food pantry provides food items for over 300 needy families each month, many are low-income seniors that live nearby. They have been open close to 25 years and continue to grow each year. The food pantry was reopened in June after being closed for

COVID safety reasons. They continue to receive food donations from other service agencies, corporations and the parish school.

Sacred Heart Food Pantry — La Porte

Food and household items are distributed monthly to the poor and needy in the La Porte/Michigan City community. The Food Pantry provides parishioners with an opportunity to use their time and talent in service to the local Church. Last year they served 992 families (3094 people) with food and groceries and non-food household items.

Pick 7 Food Distribution, St. Matthias Church — Crown Point

Pick 7 is a food pantry that serves low income families, serving 300 people quarterly. That number continues to grow as more people are made aware of the program. The food distribution program occurs quarterly and offers the opportunity to provide healthy meal options. ALL are welcome.

St Mary of the Lake Food Pantry — Gary

This ministry serves adults and the elderly in the Miller community, approximately 100 to 150 adults. The food pantry also provides winter coats for clients in need, along with hats, scarves and gloves for free distribution for the wintry season, after observing that people visiting their Food Pantry did not have access to warm, winter coats.

Boxes of Mercy - Food for the Hungry, Queen of All Saints — Michigan City

The core purpose of the Boxes of Mercy program is to provide meals for the less fortunate and assist the homeless, and to gain trust through love and kindness. The Boxes of Mercy program has provided meals for 40+ men and several women at the local homeless shelter. They anticipate an increase in women as more learn that Michigan City now offers a shelter for women.

Ways to Give



Your Catholic faith is central to your life. You care deeply about the work of the Church within the Diocese of Gary. Pair your faith with your passion through a gift that will last forever. There are many ways to create a legacy of faith through the Catholic Foundation for Northwest Indiana.

Cash

Cash is one of the easiest ways to make a charitable contribution. A cash contribution can be a check, money order or cashier's check. Donors whose gifts are matched by a company will receive credit for the matching amount. You can either establish an endowment fund or give to an existing fund.

Securities

Gifts of securities are accepted by the Catholic Foundation. The securities may be given so that the donor receives a tax deduction equal to the fair market value of the donated assets while avoiding capital gains tax on the donated assets. The Catholic Foundation will work with you to facilitate the donation of both marketable and closely held securities.

IRA Charitable Distribution

Using a Qualified Charitable Distribution (QCD) is a tax-savvy strategy that allows you to transfer up to \$100,000 per year from your IRA directly to a qualified charity, such as the Catholic Foundation. It is only available to IRAs and individuals who have reached Required Minimum Distribution (RMD). Any amount processed as a QCD counts toward your RMD requirement and reduces the taxable amount of your IRA distribution. This lowers both your adjusted gross income and taxable income, resulting in a lower overall tax liability. Check issued by Custodian must be payable to charity.

Memorial Gifts

Making a donation in memory of someone special reflects your desire to make a lasting impact on the lives of others, just as your honoree has done. You may also include the desire for memorial gifts to be made in your name as part of your final plans. Whether to establish a named endowed fund or encourage others to make individual gifts to an existing fund in your memory or that of special someone, contributions will make a difference for the Catholic cause closest to your or your loved one's heart.

Bequest

A bequest in your will is one of the simplest ways to make a charitable gift. You can specify an amount or percentage from your estate naming the Catholic Foundation to permanently benefit your designated parish, school, or other Diocesan entity or ministry forever.

Sample bequest language:

I give, devise, and bequeath to The Catholic Foundation for Northwest Indiana, the sum of \$_____ (or percentage or a description of the specific asset), for the benefit of The Catholic Foundation for Northwest Indiana and its general purposes.

Or

I give, devise, and bequeath to The Catholic Foundation for Northwest Indiana, the sum of \$_____ (or percentage or a description of the specific asset), for the creation of a permanent endowment fund for the benefit of NAME OF PARISH, SCHOOL, OR MINISTRY to be administered by The Catholic Foundation for Northwest Indiana.

Life Insurance

Life insurance is an easy way to make a significant contribution. You may give a policy that is no longer needed, take out a new policy, or name the Catholic Foundation as a beneficiary of an existing policy. Direct the proceeds, cash value of policy, or any portion of it to benefit your designated parish, school, or other Diocesan entity or ministry.

Retirement Accounts

The Catholic Foundation may be designated as the beneficiary under a donor's qualified retirement plan benefits, including IRAs, 401(k)s, 403(b)s, and Keogh (HR-10) plans. Retirement benefits may be the most tax-efficient way to make a gift to the Foundation.



Financial Summary

July 1, 2019 - June 30, 2020

The CATHOLIC FOUNDATION FOR NORTHWEST INDIANA is pleased to announce our growth to more than \$9,650,000.00 in assets as of June 30, 2020.

Since 2008, 38 different causes have entrusted their funds to the **CATHOLIC FOUNDATION FOR NORTHWEST INDIANA**; you can find a full list on page 6-7. These funds are carefully managed by CAPTRUST Financial Advisors with oversight and review conducted by our Investment Committee and our Board of Directors.

During our most recent fiscal year, our investments earned approximately \$130,000 in dividends, interest and market appreciation, despite the market fluctuation caused by the pandemic. The **CATHOLIC FOUNDATION** received \$400,000 in contributions from individuals, parishes and other diocesan organizations which increased our 35 funds to 38 funds as of June 30, 2020.

We are blessed and honored to be trusted by the Catholic community of Northwest Indiana. We strive to invest with consideration to Catholic moral teachings and responsible corporate citizenship while keeping an eye to prosperity so that the missions of our fund beneficiaries can continue to grow.

Audited financial statements for our fiscal year ended June 30, 2020 have been approved by the Board of Directors, and are available for review at the **FOUNDATION** office.


